Dr. Hinrichs approve the agenda of the September 7 and September 9, 2019 caucus meeting. No objections.

Motion by Dr. Kurkowski, second by Dr. Peckosh, to approve the minutes of the October 19 and 21, 2018 10th District Caucus meeting in Honolulu, HI. Motion carried.

Dr. Kenneth McDougall, 10th District Trustee, made brief comments regarding caucus proceedings, will not be available Sunday afternoon as he is also busy with FDI Congress activities. SF AS has 29,610 attendees registered so far with over 10,000 dentists. Not as many staff are attending. BOT agreed to fund a market research firm to analyze future ADA Annual Session meetings and possibly House of Delegates. Dr. Hinrichs asked about the future of Find-A-Dentist. First year funded by Reserves, which is usually for one-time projects. HOD did not want to fund with dues increases, so funded out of Reserves. Membership asked for another \$1 M for 10% more hits, which wasn't available. CVS agreed to promote ADA Seal of Approval products and FAD in their stores, but Aetna refused. ADA backed out of CVS agreement. FAD is still operational and part of the ADA website.

At 9 a.m., Robert Quashie (VP, Business Operations & Strategy) joined the meeting to discuss ADA Dues streamlining.

The 2019 ADA House of Delegates' resolutions were reviewed by the delegation:

- Dr. Steve Erlandson presented Budget, Business, Membership and Administrative Matters.
- Dr. Kevin Dens presented Dental Benefits, Practice & Matters.
- Dr. Aruna Rao presented Dental Education, Science & Related Matters.
- Dr. Mike Kurkowski presented Legislative, Health Governance & Related Matters.

Dr. Titze moved and Dr. Erlandson, seconded to amend the 10th District Election Rules to name the current 10th District Trustee as Election Committee Chair. Motion carried.

Dr. McDougall drew names of the four candidates for 10th District Trustee. The presentation order following the drawing is: 1) Mike Flynn; 2) Valerie Peckosh; 3) Scott Morrison and 4) Alejandro Aquirre.

By newly elected Election rules, each Candidate will be allowed to give a five-minute campaign speech with up to five minutes for questions and answers immediately before the first ballot. Only one candidate is allowed in the room during this time.

Following presentations of each of the Candidates, the Executive Directors of each state distributed election ballots for their Delegates. The Election Committee collected the first ballots and declared Drs. Morrison and Peckosh would be in the final ballot. After collecting the second vote, Dr. McDougall and the 10th District Eds counted the ballots and Dr. Scott Morrison was declared the next 10th District Trustee.

Dr. Hinrichs reviewed questions for the ADA Candidates appearing during the Sunday caucus.

David O'Doherty shared that the 10th District Social Outing will be held at Epic Steak, a 10 minute Uber drive from the Marriott. Cocktails will begin at 6 p.m. and dinner at 7:00 p.m.
