Dr. Brett Kessler, a general dentist in Denver, Colorado, is president of the American Dental Association. Dr. Kessler has held several leadership positions within the ADA. He served as a delegate in the ADA's House of Delegates from 2008 to 2019 and has been a consultant to the Council on Dental Wellbeing Advisory Committee from 2007 to 2018. He also served as the vice chair of the Council on Dental Benefit Plans. In 2010, he received the ADA's Golden Apple Award (the highest award bestowed by the Association) for outstanding leadership in mentoring.

Dr. Kessler served as president of the Colorado Dental Association from 2014 to 2015 and was instrumental in the formulation and implementation of an adult Medicaid dental benefit in Colorado.

Dr. Kessler speaks nationally on well-being and leadership topics to help dentists live their best lives. Dr. Kessler has received fellowships from the American College of Dentists, the International College of Dentists and the Pierre Fauchard Academy. He has testified before both the U.S. Congress and Colorado state legislature in an effort to help enact laws that serve the profession and the public.

Dr. Kessler graduated from the University of Illinois at Chicago College of Dentistry in 1995. He completed his general practice residency at Northwestern Memorial Hospital in 1997. Gerard Kugel, DMD, MS, PhD, is Professor Emeritus at Tufts University School of Dental Medicine and Dean at the UNMC College of Dentistry. With an expertise in Clinical Research and Esthetic Dentistry, he is a reviewer for The New England Journal of Medicine, JADA, The Journal of Esthetic and Restorative Dentistry, and the Clinicians Report. He is on the Editorial Board of The Journal of Cosmetic Dentistry, Compendium and Inside Dentistry, where he is Editor Emeritus. He is a Fellow in the Academy of General Dentistry and the Academy of Dental Materials. Dr. Kugel has his PhD in Dental Materials and earned his Executive Certificate in Management and Leadership from the Sloan School of Management at MIT.

Dr. Kugel has published over 200 articles and over 400 abstracts in the field of restorative materials and techniques. He has given over 400 lectures both nationally and internationally and has done funded research on a wide range of topics. Dr. Kugel spent 38 years in private practice in Boston and is presently practicing with University Dental Associates in Lincoln, NE.



Dr. Gregory W. Bennett, DMD

Dr. Bennett is an Associate Professor and Interim Department Chair of Adult Restorative Dentistry at the University of Nebraska Medical Center College of Dentistry. He is originally from the West Coast and earned his Doctor of Dental Medicine degree in 2010 from the Oregon Health and Sciences University School of Dentistry, and followed on with a general practice residency at the Naval Hospital Camp Pendleton. Dr. Bennett served in the United States Navy as a Dental Corps officer for over five years with time spent in California, Mississippi, Kuwait, Afghanistan, and Hawaii. Dr. Bennett left the Navy in 2015, and began teaching at the UNMC College of Dentistry and practicing in a technology focused private practice in Lincoln, Nebraska. Dr. Bennett also performs research on dental technology with a focus on 3D printing.
