 - Recreated the Medicaid Advisory Committee (MAC) who recommends policy, education programs, and champions state reforms



Goals

Increase the number of Medicaid providers with claims for Medicaid beneficiaries by 5–10%. Increase the number of Medicaid providers with claims for more than 100 Medicaid beneficiaries by 5–10%.



Approach

Leadership Champions

Promote continued partnership and a shared vision to improve oral health outcomes amongst Medicaid beneficiaries.

Collaboration

Engage in state-based teams to establish strategic goals. Participate in a Collaborative (quarterly) with CMS.

Evaluation (Data)

Establish Medicaid data / surveillance analysis to achieve goals and monitor trends. Engage in evaluation practices (state-based & within the Collaborative).

Overarching State Pilot Strategy




State-Driven Systems



Expected Outcomes & Affiliated Actions

- Improve Provider Participation & Patient Utilization
- Address Barriers to Care
- Increase Community Dental Health Coordinators (CDHC)
- Data sharing for children and adults
- Conduct dentist surveys on reasons for participation or nonparticipation in Medicaid
- Support with legislative initiatives such as dental loan repayment based on Medicaid engagement
- Best practices on age 1 dental home and ED deferrals for nontraumatic dental visits
