President's Message

On July 26th we had a Legislative workshop with about twenty-five in attendance. Most were new dentists. Our half day training consisted of reviewing

recent bills that have passed, upcoming bills for 2025, learning how a bill moves through the Legislature, and advocacy training by the ADA staff. The evaluations were very positive, and I recommend we do this every other year.

I am happy to report the ADA has awarded the NDA with a \$50,000 grant to help provide us with resources to pass our legislative bills (MLR, Medicaid fee increase, oppose the anti-fluoride one) as well as help us brainstorm and develop a plan for dental workforce issues. A huge thanks to **David** for crafting a great grant application. We asked for and received \$50,000. This means we MUST have all hands-on deck working to pass our bills to assure the ADA BOT that their investment in Nebraska pays off.

The Dental Medicaid Collaborative continues to have monthly meetings with suggestions for changes for improvement. Currently, we are discussing incremental payment for dentures and how to improve the no-show issue. We

are presenting to five other pilot states in September at a virtual meeting.

On August 1st, I participated in the 10th District Caucus to make plans for the ADA House of Delegates meetings in October. I have also been asked to speak on Medicaid at the conference. The most interesting part of the meeting was the ADA staff talking about changes in Medicare and what discussions are beginning to occur. David also laid out the plan for all meetings and social events as the NDA is hosting and organizing things this year. **David** and **Jody** have been very proactive planning our 10th district events in New Orleans.

On April 5th, I attended the annual Adam's County Dental meeting that conducted mock interviews for six local Hastings's students. This is a wonderful opportunity for local dental societies to mentor the next generation of dental students and our future colleagues. Please contact me if you want details of how we organize this.

On August 16th, Jody and I met with the University of Nebraska Athletic Department staff and proposed our April annual meeting social at Memorial Stadium. We are incredibly pleased that they said we can have our party there. This will be for all members, families, and dental team members. It will be kid friendly. Activities we requested are tours of the stadium, allowing the kids to run on the field, running out to the tunnel song, and dining in the west



club house. I am extremely excited and hopeful this will bring in members and especially new dentists who otherwise might not come.

On August 22nd, I briefly attended the ODDS meeting and gave an NDA update on activities. Finally, I have had multiple meetings with David and Jody planning the NDA annual session.

Future meetings for the Fall include the Board of Dentistry meeting; a meeting with the new DHHS Secretary, **Steve Corsi;** and giving a lecture on Medicaid to faculty by invitation of the Dean at UNMC.

Fluoride Report Walks Back Its Original Findings

American Fluoridation Society

The National Toxicology Program (NTP) released a report about fluoride on August 21 that backtracks significantly from its original draft, which failed to complete the peer review process. The final report has removed NTP's original assertion that fluoride is a "presumed" neurodevelopmental hazard. NTP concludes that exposures to fluoride in drinking water above 1.5 milligrams per liter are associated with lower IQ scores. This level is more than double the fluoride level that is used for water fluoridation in North America.

The CDC reports that fluoridated water reduces tooth decay by 25% for children and adults. This is an important benefit because tooth decay is the most common chronic disease for children and adults in the U.S.

Several years ago, NTP asked the National Academies of Sciences to serve as peer reviewer for its draft report. The National Academies reviewed the report twice and raised numerous concerns — many of which were not addressed. The National Academies advised NTP to "make it clear that the monograph cannot be used to draw any conclusions" about low fluoride exposures, such as "those typically associated with drinking-water fluoridation."

NTP states that its final report "was not designed to evaluate" the health effects of fluoridated tap water nor did it collect enough data to perform that task. In addition, NTP itself said it has only "moderate confidence" in the fluoride-IQ association that it found.



Public health experts point out that association does not equal causation.

Although the NTP report does not reach any conclusions about water fluoridation, the American Fluoridation Society urges the public to be aware of the report's weaknesses.

For example:

- Research quality is a key concern because 62% of the studies reviewed by NTP were published in less reputable journals. In fact, these studies came from journals that the National Library of Medicine does not index, meaning it doesn't consider them worthy of including in its enormous research collection.
- Many of the studies reviewed by NTP relied on spot urine samples, which are not a reliable way to measure an individual's exposure to fluoride.

NTP's report justifies this method of measuring exposure by citing and misinterpreting a 2010 research paper. This paper explains that spot urinary fluoride samples can offer "reasonably good estimations of community-based" exposure but are not "a precise estimator" of daily fluoride intake "on an individual basis."

Many studies in NTP's report suffered from errors or weaknesses in their methodology. For example, in some studies, the IQ tests were administered in ways that weaken the reliability of the scores. NTP cited a 2012 research review (Choi, et al.) as "showing the precision of the association between fluoride exposure and IQ" but overlooked the fact that the review's authors reported that each of the 27 studies they analyzed "had deficiencies, in some cases rather serious ones, that limit

the conclusions that can be drawn."

Communities should not be misled by people who try to use the NTP report to push for an end to water fluoridation. The only concerns raised by the report apply when the level of fluoride in water is more than double the level used for water fluoridation.

The public should know that researchers in a variety of countries have examined the safety of fluoride in drinking water and found no link to cognitive deficits:

- Studies from Australia, New Zealand and Spain (each of which has water fluoridation programs) show no link between fluoride exposure and cognitive deficits. In fact, the study from Spain showed that fluoride exposure was associated with better cognitive performance by boys. The New Zealand study tested IQs multiple times over a 31-year period, enhancing the strength of its findings.
- 31 European experts in toxicology and food safety examined numerous fluoride-IQ studies and concluded that the overall evidence "does not support the presumption that fluoride should be considered as a human developmental neurotoxicant" at typical exposure levels in fluoridated water.
- A research review in 2023 examined the quality of 30 fluoride-IQ studies. All but one of the 30 studies were assessed

as having a moderate or high risk of bias. The only study with a low risk of bias found no link between fluoride exposure and IQ scores. A former NTP director co-authored this review.

Steven Novella, a clinical neurologist at the Yale University School of Medicine, has reviewed many fluoride studies. In a 2023 article, Novella called water fluoridation "safe." He added that there is "a potential of neurotoxicity from fluoride at high levels, significantly higher than in the drinking water. But the same data shows, if anything, the managed drinking water levels are safe. Further, the best quality evidence does not show any clinical effect."

Dr. Johnny Johnson, president of the American Fluoridation Society said health officials and parents should take care in interpreting the NTP report. "Even the NTP report states that its finding does not apply to water fluoridation."

The safety of fluoridated water is backed by more than 75 years of research and experience. Fluoridation is recommended by the leading health, dental and medical experts, including the American Academy of Pediatrics, American Dental Association, and the American Academy of Family Physicians.

Tooth decay is the most common chronic disease for U.S. children and adults. Drinking fluoridated water reduces tooth decay by 25%. Research shows that when a city ends fluoridation, tooth decay goes up. This is what happened in Calgary and Windsor, Canada — and why city councils in both cities voted to resume fluoridation.

Dr. Johnson welcomed new research in this field. "I'd like to see a well-designed prospective study to measure and compare cognition between areas with high and low levels of naturally occurring fluoride. Some areas in the U.S. have naturally occurring fluoride above 2 milligrams per liter," he said. "The National Institutes of Health has funded cognitive studies in other countries, but these studies have suffered from various deficiencies. Let's use our U.S. taxpayer dollars to fund a study here."

NDA Receives State Public Affairs Grant

Assistance For the 2025 Legislative Session

The NDA applied for and recieved a State Public Affairs Grant from the ADA this summer. The NDA will work with *Krantz State-gies*, who assisted the Illinois State Dental Society last year - shown below. Issues include **Dental Insurance Reform** - During the 2024 Legislative session, the NDA introduced LB 1110, requiring dental plan carriers to meet a minimum dental loss ratio and provide a report to the Department of Insurance as prescribed. **Water Fluoridation** – Senator Hansen will re-introduce a bill mirroring 2024's LB 1387 that would require communities to place a fluoridation measure on the ballot affirming that they want to continue fluoridating their water. **Medicaid Goals** –Last year, the NDA introduced LB 358 in the Health Committee, requiring an increase in dental Medicaid fees by \$6M (25%). LB 358 was amended and passed, with a 12 ½ increase, but was not included in the first draft of the Appropriation Committee's Budget. **Workforce Goals** – Nebraska is facing a shortage of dental assistants and hygienists. NDA plans to boost the number of middle school and high school students in Nebraska considering a career in dental hygiene or dental assisting.

ILLINOIS PUBLIC AFFAIRS CASE STUDY

ILLINOIS STATE DENTAL SOCIETY

Illinois dentists have sounded the alarm for too long on an issue that has dramatically affected the health outcomes of their patients for decades – the pressing need for insurance reform. Despite increasing dental insurance premiums, patients experience frustration as their dental benefits diminish. Sporadic and limited benefits have meant patients are regularly denied coverage on the most basic services.

Building on recent patient-centered dental insurance victories in Massachusetts, the Illinois State Dental Society engaged Krantz Strategies to develop and manage a strategic public relations campaign advocating for dental insurance reform legislation in Illinois.

Strategies

- Framing proposals as patient-centered initiatives.
- Leveraging web, digital advertising, video, social media, and media relations.
- Hosting a press conference to launch the campaign.
- Producing an engaging video outlining the importance of reform.
- Utilizing targeted digital and social media.
 Creating fact sheets, social graphics, and a toolkit for stakeholders.
- Engaging in proactive media relations including securing a letter to the editor by a member in the Chicago Tribune.
- Tailoring messages during legislative hearings.

Key Results

- Two out of three bills were signed into law by Governor Pritzker.
- More for Your Smile positively impacted dental professionals and patients.
- Metrics included 65,000 video views on YouTube.
- The campaign successfully engaged ISDS membership and fostered unity in advocating for dentistry and oral health.
- The campaign's success resulted from collaboration, effective messaging, and strategic media engagement. Lessons learned include the importance of cohesive messaging, data-driven advocacy, and continuous stakeholder


